Anyone can nominate another person, or themselves, to be on the board, or to be an officer on the board. All nominations must go to the commissioner for approval after the April 21, 2025 meeting. The current board members can let us know at the February 2025 meeting if they want to continue in their current roles. Nominations for new members are treated the same as current members staying in their current role – they are ALL considered nominees that must be approved.

- c. The following are suggestions from community members:
 - i. Add deadline to handing out the initial GNN?
 - 1. Patrick Woodall motioned to amend the ordinance to adopt a deadline of 15 business days, or before the first rental, for handing out the GNN after obtaining

the INITIAL license, Karen Sweeney seconded. The motion passed unanimously.

- ii. From the "Definition" section of the ordinance: "Good neighbor notification means a document provided by the property owner/registered agent to surrounding properties annually." Do we want to amend the section titled: Operational requirements for owners" to include the word "annually"?
 - 1. Patrick Woodall made a motion to add the word "annually" to the section of the ordinance entitled "Operational Requirements for Owners". Karen Sweeney seconded. The motion passed unanimously.
- d. Request by Joni Lee, owner of Suches Vacation Rentals, to speak to the board. She suggested that the board invite Mitch Griggs, Director of the Union County Development Authority, since accommodations is the third leading category of tourist dollars coming into Union County. She also let us know that she feels the GNN isn't working because the tax records are not correct, therefore so many GNN's don't get to the neighbor. She suggested that all property management companies be listed on the county website so people can call even if they didn't get the GNN.
