Agreement Amendment between CorrectHealth Union, LLC and Union County for inmate health service at the Union County Jail. This is a renewal of a 12-month contract effective January 1, 2025, for a contract total of \$192,431.60.

8. Agreement Amendment

Agreement Amendment between S&L Integrated Systems, LLC and Union County in the credit amount of \$1,566.00. The original agreement was for new and updated equipment in all courtrooms, the Grand Jury Room and the Jury Assembly Room in the Union County Courthouse in the amount of \$449,999.01. This agreement decreases the total amount of the original agreement by \$1,566.00 due to change orders in the scope of work and materials needed. The funding for these upgrades will be provided through the Judicial ARPA Grant and Union County will be reimbursed at 100% from this grant.

9. Business Licenses

Approval of Business Licenses issued in Union County from October 14, 2024 to December 15, 2024 for the purpose of operating a Short-term Rental in Union County. A list of issued business licenses is attached and made part of this Agenda.

10. Deed of Easement

Deed of Easement between Cameron S. Hill & Cooper J. Hill and Union County for nonexclusive perpetual easement for only the purpose of relocating Groundwater Monitoring Well CWC-14 along with a limited easement of ingress and egress to maintain, monitor and repair the well on a certain tract or parcel of land located on 1159 Deep South Farm Road, Blairsville, GA 30512 specifically Deed Book 1125, Page Number 629.

Lease Agreement between Positive Pathways, Inc. and Union County for the use of office and meeting space located at 243 Hunt Martin Street, Blairsville, Georgia in the amount of \$0.00 per month. The duration of this lease will be from December 1, 2024 to November 30, 2025.

Lease Agreement between Appalachian Veterans Memorial Park, Inc. and Union County for the property located on Patriots Way, Blairsville, Georgia for the purpose of displaying the Veteran's Memorial, its related monuments and continuous sidewalks as well as activities related to ceremonies, education and common public viewing. The term of this lease commences on December 19, 2024 and ends on December 31, 2034. The cost of this lease is \$1.00 per year.

16. Lease Agreement

Lease Agreement between Union County Hospital Authority and Union County, a Political Subdivision of the State of Georgia for the 2.0 acres of real property and the facility as shown in Deed Book 189, page 584 with the address of 683 Ledford Road, Blairsville, GA 30512. The cost of this lease is \$1.00 per year with an effective date of January 1, 2025. This facility is being utilized as a child care facility operated by Union County Hospital Authority.
